President's Message

Once again at the March HMC Board meeting issues arose about members and possible guests not respecting other member's or HMC property. It is very discouraging to volunteers and staff to have to deal with cleaning up after some people vandalize community property. The Board authorized some barriers to be placed around Goodpastor Park to try to limit driving on the fields. Those that drive vehicles and ATVs on the fields leave ruts that needs to be filled in and replanted. All this takes volunteer effort and should really be unnecessary. All members need to be aware of the impact of their actions on other members and the community as a whole. HMC property including parks, lots, and road right-of-ways belong to all of us and need to be protected and respected. We don't need the cost of additional security and legal action if members would show more respect and even report such activity.

The Board also had to adopt a policy on use of coins to pay HMC fees and fines. The Board put a \$2.00 limit on acceptance of coins for all HMC fees including ferry fees. The time and inconvenience it takes to sort, count, and roll the coins before we can deposit them in the bank is really unnecessary. This issue and policy would not be needed if members again showed more consideration for the ferry crew and office staff. HMC has a very dedicated group of employees and staff that we are lucky to have. We should strive to help them as much as possible. Even little things like having the correct change for ferry fees makes life easier for both the crew and office.

The water committee has been working very hard over many months detailing options that will impact all of us in many ways. The amount of effort put in by members of the committee is extraordinary and generally not fully appreciated by members not involved. The board is going to meet with the committee this month to try and resolve several conflicting approaches on how to proceed. More information will be forthcoming in the near future. As one might expect with issues and costs so large, there

are heated discussions and strong opinions on how we as a community should move ahead.

Finally, we are approaching the budget cycle for our next fiscal year. The various committees are putting their budget proposals together. I, as treasurer, met with our Island accountant to revise the chart of accounts to better support the budget and audit functions. We have expanded the multi-year funding approach using reserve accounts. The engine overhaul for the ferry is now separate from the dry-dock cycle and on a three year cycle rather than the two year cycle for dry-dock. This saves the Island a large sum of money, which will slow the rate of assessment increases. Further, this will detail the accrued expense, which will make the audits more understandable. Right now, audits show losses or deficits in the years where dry-dock or engine overhaul occur and surplus in the off years. In the past, expenses for these items had to be booked against the source of funding (like withdrawals from reserve accounts) rather than against the actual expense account. This will be the first year using the new set of accounts where deposits and withdrawals from reserve accounts are actually budgeted in their own right.

- **Plan your arrival at the dock at least 5 minutes before the scheduled time of departure.**
- **Walks-ons are not to be on the dock or ramp when cars are being loaded. Watch crew for permission to board.**
- **Only service and delivery people may charge fares.**

WE HAVE EXPERIENCED GUESTS AND SERVICE PEOPLE EXPECTING TO COME OVER TO THE ISLAND WITHOUT GUEST PASSES. THIS VIOLATES THE ACCESS POLICY THAT WAS PUT IN PLACE FOR ALL OF OUR SECURITY. PLEASE MAKE SURE YOUR GUEST HAS A VALID GUEST PASS SIGNED BY YOU TO ENSURE THEY ARE ABLE TO RIDE THE FERRY. BLANK GUEST PASSES ARE AVAILABLE TO MEMBERS AT THE OFFICE, BY MAIL, AND ON THE FERRY.

**HMC Management
Board Meeting Summary
March 8, 2008**

Administration

- The attorney has been asked to further refine the Ferry Access Policy and the Tenancy Agreement so that they conform to Bylaws language and the Board's intent.
- The Board instituted a new policy that states that HMC is not required to accept more than a maximum of \$2.00 in coins for payment of HMC bills, ferry fees and assessments.

Land Use

- Viking Fence provided a bid for fencing along the south and east boundaries of the Nature Park. The Board decided to look into doing the job with a volunteer work party using steel fence posts.

Legal

- Trees on a stretch of road near the North Beach were cut without permission from HMC, which violates the Rules. Follow-up on this issue is in progress.
- The attorney is looking at some proposed Bylaws changes.
- All delinquent accounts are now at the attorney's office.

Transportation

- E-mails recently received from Associated Petroleum indicate that they will move forward on presenting an alternate fueling plan to the State Department of Ecology.
- Planning is underway to identify the additional reserves that will be required for ferry drydock work, including a new pilot house ladder and new shaft tubes. Also, adequate reserves for future engine replacement and repairs to dolphins and the steel transfer spans (ramps) at the two ferry terminals.

Water

- A lot of discussion regarding the Water Committee's work on and recommendations at this point to the Board took place. Work to calibrate existing source meters and to add an additional meter required by State regulations will commence shortly. Other recommendations will await a joint Water Committee-Board of Directors workshop to be held later this month. More information from Washington Water Company is expected prior to the workshop.

Annual Burn

The Annual Island (North Beach) burn is scheduled for May 17th. Members may take yard waste to North Beach May 3-16. No trash, building materials, roots, or stumps are allowed.

Payment in Coins

The Board of Directors of HMC Management has determined that HMC will no longer accept more than \$2.00 in coin for payment of any fees or assessments, including ferry fees. Amounts of coin in any one transaction greater than that create problems for both the ferry crew and the office in handling, counting and rolling coins for bank deposit.

Water Meter Letter Update

Update to the "Rough Draft" letter regarding contiguous lots that was on Page 9 of the last Beachcomber: While it is true that new water laws require the eventual installation of water meters for all customers on a water system, information obtained from the State indicates that having a meter on a particular property does not in itself determine eligibility for a future water hookup. If a system has the capability of providing water to a customer then it must do so when asked. That said, the Water Committee will still need to have a reasonably accurate picture of who is likely to want hookups in the future, as lots continue to be developed. This information is essential for planning the water system upgrades.

Tree Cutting

Please remember that cutting trees or doing any other work on HMC road rights-of-way, without first obtaining an Encroachment Permit issued by the Island Manager, is prohibited and constitutes a violation of the Rules. The only exception to this is routine ditch maintenance work done by an owner along the street frontage of his or her property. The right-of-way along most roads is typically 50 feet wide and the area traveled upon by vehicles is only a portion of the right-of-way.

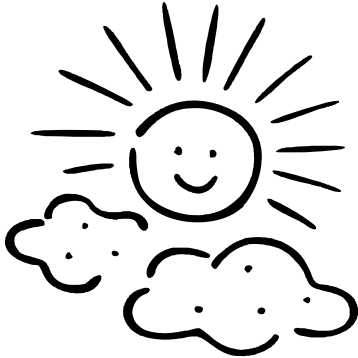

Water Committee News

The water committee is pleased to report we are making progress. New information surfaces daily through our research, contacts and attending water seminars. The goal of our committee is to research ALL avenues for information concerning Herron Island Water System and present clear and factual information.

- We are meeting with the Board, Thursday, March 20th to inform them of our progress and agree on the next step to take.
- We will be visiting all properties to count and locate current connections and determine the connection size.

Throughout our research we continue to have two major considerations: Determine the feasibility of Retaining Ownership or Transferring Ownership of our water system:

- We have received PenLight's proposal to Transfer Ownership
- Washington Water intends to provide a proposal in the near future.
- We have been diligently working to develop the Retain Ownership option since mid November.

In the meantime, we ask all members to take a look at the chart below and note the amount of water one small leak can waste.
