## President's Message

As usual, many issues surfaced during our September HMC Board meeting. We seem to be on track to ending our fiscal year at the end of this month with the \$40,000 we predicted as a carryover into next year's budget. We used this carryover to reduce the size of the assessments for next year but still had a large increase that you voters approved in July. There was member concern that with the economy as it is and prices increasing, that we delay the assessment increase for a year as some of the increase was funding reserves for future expense. The opinion of the board and most members attending the meeting was that this concern is valid but that conditions are not likely to be significantly different next year so to delay funding our reserves would be a bad choice. We had better start the funding now so that even larger increases in future years could be avoided. Some members wanted to know if payment options could be offered for paying assessments (such as monthly or quarterly rather than semi-annually). We did institute the credit card option this year and have followed other government property tax approaches that bill semi-annually. We do allow, however, members to pay quarterly or monthly in advance if they wish even though we will only bill semi-annually. That is, a member may prepay the billed amount on a monthly or quarterly basis as long as the total bill is paid up when due.

The new fee schedule goes into effect October 1st with increases in most HMC fees and ferry user fees. The board elected to maintain the policy that old tickets or passes could be used but additional collection would be made for the new ferry fees.

The school district changed their schedule and delayed the start of school on Wednesdays for some elementary school children by one hour. While it impacts only one child, the issue of adding an additional 9:30AM/10:00AM run on Wednesdays was addressed that would allow the child to be picked up by the revised

school bus schedule. While most agreed that adding the run for the sole purpose of reacting to this schedule change for just one child was not warranted, the run would aid a number of commercial deliveries to the Island. Many companies will only come on Mondays with that extra run so they can get on and off the Island without major delays. By adding this run on Wednesdays, it will provide more opportunities for both commercial and member access. The ferry crew felt that this run mid-week would be used by many and the fees might well cover the incremental costs. The Board elected to pilot this Wednesday run through June 2009 to accommodate the school issue and see if the actual use justified the schedule adjustment.

I received an e-mail from a mainland neighbor (lives along the road to the ferry dock) complaining about Herron Island residents speeding to catch the ferry. They are concerned about their children and pets and noted that Herron Island has a 15 MPH speed limit. Why they ask are we willing to protect our children, wildlife, and members when we ignore theirs. Out of common courtesy, we should respect their concerns for safety and watch our speed going to and from the ferry dock.

There was an issue on Island security where vandalism and theft seem to be on the increase. In years past, there have been neighbor watch and patrol activities to try and deter such activities. Some volunteers may be looking into starting this again and using other technology to determine who is behind this. We have instituted a new information approach whereby information will be posted on the Web Site (before and in addition to the Beachcomber) on alerts on these types of issues and other timely issues. Board Member Janet Podell will act as a focal point for approving these timely alert messages to be dated and put on the Web site.

Finally, you will read in this issue that the Herron Island Boosters are disbanding due to nobody stepping up to be officers of the organization. The Boosters have been a great support (both volunteerism and financial) to the Island and will be missed. The problem is that the support and volunteer load is carried by too few on the Island. We cannot expect the few that have been doing

this over the years to shoulder the entire load. We need new members to step up to sharing some of the volunteer activities. Please think of ways you can help and share in support of the many functions that keep our Island a great place to live and vacation. Thanks to all the Boosters for all you have done.

Water on Herron Island continues to be of highest quality. We just passed a once every three-years test for lead and copper with a **very satisfactory**. One of our pumps needed to have the motor replaced which was completed and now we are up and functioning well. We have upgraded our system with a new source meter which will give us a more accurate reading of water pumped from each well.

Mike Davis spent many volunteer hours working on our system and wishes to thank volunteers: Todd Stone, Dick Zottman, Karl Shafer, and Scott Schultz for assisting with work that needed to be done.

We are fortunate to have an abundance of good clean drinking water for our island. By continuing to conserve our water usage, we provide a reliable supply of water for our immediate future and for years to come. Please shut off your water at the supply shut-off when you leave the island for any period of time. Report any leaks on the island side of your shut-off valve to Mike Davis (884-1423), our water chairman or to the office.

Island Manager Report  
Board Meeting  
September 13, 2008**

Administration

- The ferry will be in dry dock between September 14 and (tentatively) September 24. The actual date of completion is not determined. It could be after the 24<sup>th</sup>, depending on the job progress.
- A security officer has been contracted for the period the ferry is in dry dock. The officer will patrol the mainland parking lot during night hours.
- For Board discussion: whether, and how, to bill owners for false fire or burglar alarms that result in overtime costs to HMC for ferry runs to pick up emergency responders.
- For Board discussion: whether to initiate a regular pest control (mainly carpenter ant control) for the Community Building, as recommended by a pest control company that recently treated the building.
- This report was prepared on September 2, 2008.

Information Items

- New island resident Todd Stone was instrumental in helping to get the water system running immediately after it suffered electrical damage to various components.

Legal

- The Rucks property, long delinquent, was up for auction on September 5.

Roads

- North Beach road has been repaired following a septic system tight line project. The amount of the deposit to be refunded is less \$200.00 expense that HMC incurred for rock used in the resurfacing of the road.

Rules

- A new Rules member, Regina Everett, is proposed by the Chair.

Transportation

- The ferry will leave the island Sunday, September 14, after 4:00 PM, for dry dock.

Water

- The survey of island roads has reached the amount funded by the Board. To complete the survey, additional funds (with a maximum of \$6000) will need to be allocated.
- Another reminder to all owners: please shut off the water to your property when leaving the island for an extended period.

Herron Island History Cont....

#### Herron Island Development

There it was in the mail, late summer of 1958, a letter from Realty Sales Inc. complete with map, inviting us to come and spend the day on the beautiful private island in Puget Sound. Letters were sent to thousands of people in the northwest from Portland north to Everett and placed ¼ page ads in all newspapers around Puget Sound. They had developed it into an ideal recreational area, away from the city, where you could relax and enjoy all the many interesting sports, fishing, boating, swimming, etc., etc.

It was served by a private ferry which would restrict outsiders, unwanted guests, etc. and we could own a buildable lot on this island for only \$95.00. That's right, \$95.00

Well, when something sounds too good to be true, it generally is, too good to be true. But, we had to go and see, so we did.

We followed the map and got to the ferry dock to find no ferry, but cars waiting to go to the island. When we stopped, the man in the car ahead got out, pulled out a pair of crutches, and came back to talk to us. He introduced himself as Ed Adams, and was boiling over with enthusiasm and lots of good news about Herron Island. Ed Adams was the first Herron Island Maintenance Co. president.

There was a loud horn on the ferry ramp that called the ferry to come and pick us up, and he had already blown it, but by the time the ferry arrived he had sold us on the Island.

We drove onto the "Annabelle S" and enjoyed the ride to the Island, the drive to the north community beach, where the sales office was set up for the day. Actually, the office was in one of the two houses to the left of the road to the beach, now occupied by Jack and Nancy Wells. There we met "Roger", the chief sales person for "Realty Sales", the company set up by the Clifford Brothers, the developer. They had previously developed "Tapps Island", on Lake Tapps, then bought "Reach Island", and renamed it "Treasure Island", and developed it. They bought "Herron Island" for \$50,000 then moved south down Hammersley Inlet and developed an area there too.

Roger explained the program to us. The island lots were almost all \$1,500 to \$2,000 and the waterfront lots were \$3,500 to \$4,000. But there was one lot priced at \$495

that we could buy for \$95. All the regular lots had water hook-ups included in the price, but the \$95 lot did not, and would cost an extra \$250 for water.

Then he drove us all around the Island, every lot had a view, and showed us many lots, but we wanted to see the \$95 lot. Finally he took us to see the "lot". It had been a corner lot, about 110" X 120", split in two, to make two small lots, which he guaranteed to be legal building size.

The roads had just been built, and there had been a lot of grading, and rain, so silt had washed down and spread over this lot, so it looked like a beach. I took a second look and found there was a good drainage ditch just behind the lot, but a bulldozer had made a track like a dam, which held the silt and water.

Over his objections, we bought the lot, and didn't go back until spring. In the meantime the sales people continued to show this lot as the \$95 lot, but when someone tried to buy it, they had to admit it was sold, so they spilt a 79 foot lot on the hill above, and sold him a 40 X 220 foot lot for \$95. They eventually sold several \$95 lots. The water and silt on our lot turned out to be a blessing, by adding a good thick layer of topsoil to the property and leveling it. George Newcomb and family built what was commonly called the "star house".

Within 3 years all of the lots were sold and Realty Sales, who had originally set up a Board of Directors consisting of development people and Island members, turned the entire "Board" of seven members over to the Herron Island Maintenance Co. with the Articles of Incorporation, the "covenants" which were good for 25 years, and the By Laws, made up by the developers.
